Privacy Policy

This Privacy Policy (the "Policy") is an integral part of Diamond public s.r.o. IČO: 07910584, with its registered office in Žďár nad Metují 18, 549 55, registered at the Regional Court in Hradec Králové under file number C 43393 and agreed pursuant to Section 1751 et seq. disciple. No. 89/2012 Coll., Civil Code, as amended (hereinafter referred to as the "Diamond Public Company"). Diamond public takes care of the protection of your personal data in accordance with valid and effective legislation, which since 25 May 2018 is mainly Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on free movement. these data (hereinafter referred to as the "Regulation").

Diamond public is the operator of the websites sex-czech.cz, sex-poland-private.pl, sex-slovakia.sk, szexpartner-hungary.hu and others (hereinafter referred to as the "Portal"), through which it provides its services (hereinafter referred to as "Services"). The Policy applies to all personal data processed by Diamond public on the basis of the fulfillment of a contractual relationship, legal obligation, legitimate interest or granted consent, through the Diamond public Portal. The policy describes Diamond Diamond's use and protection of personal information.

Diamond public may amend this Policy at any time by posting a revised version on the Portal, and such amendment shall take effect on the date of such posting.

1. ADMINISTRATOR AND HIS CONTACT DETAILS

1.1. The controller of personal data within the meaning of Article 4 (7) of the Regulation is Diamond public.

1.1. The controller of personal data within the meaning of Article 4 (7) of the Regulation is Diamond public. Diamond public has not appointed a data protection officer within the meaning of Article 37 of the Regulation.

2. PERSONAL DATA PROCESSED BY Diamond public

2.1. Personal data means any information about an identified or identifiable natural person. An identifiable natural person is a natural person who can be identified, directly or indirectly, in particular by reference to a specific identifier, such as name, identification number, location data, network identifier or one or more specific physical, physiological, genetic, mental, economic, cultural or cultural elements. social identity of that natural person.

2.2. Diamond public helps so-called cookies and internet beacons in providing the Services. You can find more detailed definitions, types and purposes of their use by Diamond public in the Policy below.

3. PURPOSES OF THE PROCESSING OF PERSONAL DATA

3.1. Diamond public processes your personal data for the following purposes:

pre-contractual negotiations;

fulfillment of the contractual relationship (the relationship between you and Diamond public, which arose from the registration of the user of the Services);

administration of user accounts (ie in particular compliance with your request for the Service, establishment of your account, administration of your account and ensuring your access to the Service and its updates);

contacting in order to solve problems related to the use of the Service or the Portal;

sending information about the Service (ie confirmation, notification, updates and supporting and administrative communications);

displaying ads based on your interest;

fulfillment of Diamond public's legal obligations

4. PROCESSING OF PERSONAL DATA FOR THE FULFILLMENT OF THE CONTRACTUAL RELATIONSHIP

4.1. In the case of your registration as a user of the Services, personal data are processed in accordance with the provisions of Article 6, paragraph 1, letter b) Regulation - the provision of personal data a necessary requirement for the performance of the contract or for the implementation of measures taken before the conclusion of the contract at the request of the data subject. Without the provision of personal data, it is not possible to negotiate, enter into a contract or perform it by Diamond public.

5. GRANTING CONSENT

5.1. You have the right to revoke the consent granted to Diamond public with the processing of your personal data at any time, via an email sent to Diamond public's email address info@diamond-public.cz stating your name, surname and address due to your identification. Withdrawal of consent does not affect the lawfulness of processing based on the consent given before its withdrawal.

6. PERIOD OF PROCESSING OF PERSONAL DATA

6.1. Personal data will be processed by Diamond public:

in the case of processing personal data on the basis of registration - for the period of registration;

6.2. After the retention period of personal data, Diamond public will delete the personal data.

7. PROVISION OF PERSONAL DATA TO THIRD PARTIES

7.1. The recipients of your personal data are suppliers, consultants and other service providers who cooperate with Diamond public. These third parties need access to your data in order to carry out their activities. Diamond public does not currently work with anyone.

7.2. Diamond public does not provide your personal information to third parties other than those listed above, nor does it share it with other individuals or unrelated companies, except in the following cases:

compliance with or in response to regulatory requirements;

the protection of the rights and property of Diamond public, its agents, users and others, in particular for the purpose of enforcing its contracts, policies and terms of use and, in urgent cases, to protect the own security of Diamond public, users of its services or any other person;

in connection with or during any merger, sale of Company property, financing or acquisition of all or part of Diamond Public's business by another company.

7.3. Diamond public will not transfer your personal data to a third country or international organization without your consent, unless this is necessary for the performance of the contract between you and Diamond public or such obligation arises for Diamond public by law.

7.4. Diamond public does not provide any personal data collected through the Portal or the Service to third parties for direct marketing purposes without your consent.

8. DATA SUBJECT RIGHTS

8.1. As a GDPR data subject whose personal data is processed, you have the rights below, which you can exercise at any time. It is about:

the right to access your personal data (ie the right to obtain information on whether your data is being processed and, if so, the right to access it);

the right to correct personal data (ie to request correction if you find that Diamond public is processing inaccurate or false data);

the right to request an explanation (ie if you suspect that the processing of personal data violates the protection of your personal and private life or is being processed in violation of the law);

the right to restrict the processing of personal data (ie the right to request a temporary restriction on the processing of your personal data);

the right to delete personal data (ie if your data are no longer needed for the purposes for which they were processed);

the right to object to the processing of personal data (Diamond public is obliged to prove that there is a serious legitimate reason for the processing of personal data which outweighs your interests or rights and freedoms);

the right to data portability (ie the right to request that your data be provided to a third party);

the right to withdraw your consent to the processing of your personal data at any time;

the right to lodge a complaint with the Office for Personal Data Protection (ie if you believe that your right to personal data protection has been violated).

9. SECURITY MEASURES AND COMMUNICATION OF PERSONAL DATA

9.1. Diamond public secures your personal information in accordance with the highest security standards, through a wide range of security measures, including encryption and authentication tools, to prevent and maintain the unauthorized access, alteration, disclosure or destruction of your personal information. Your personal data is protected by firewalls and is accessible only to a limited number of people who are obliged to keep this data secret.

10. COOKIES AND INTERNET BEACONS

10.1. In order to provide you with services tailored to your needs, Diamond public uses so-called cookies (session ID cookies and persistent cookies) to store and occasionally monitor your visits to the Portal. A cookie is a small text file that is stored on your computer for recording purposes. Diamond public uses cookies to make it easier for you to navigate the Portal. After closing your browser, the session ID cookie expires. A permanent cookie stays on your hard drive for a long time. Diamond public checks to see if JavaScript is enabled in your browser to facilitate the browsing of the Portal. Most internet browsers are set to automatically accept cookies.
